

DANONE NUTRIDAY SMART SHOPPER COMPETITION TERMS AND CONDITIONS

1. TERMS AND CONDITIONS

1.1. The promoters of this competition are Pick n Pay Retailers Pty Ltd (registration number: 1973/004739/07), a company incorporated in the Republic of South Africa with its registered address at 101 Rosmead Avenue, Kenilworth, 7708 ("Pick n Pay"), and Danone Southern Africa (registration number: 1996/000869/07), a company incorporated in the Republic of South Africa with its registered address at 199 Bryanston Drive, Bryanston, Sandton. Pick n Pay and Danone Southern Africa shall collectively be referred to as the "promoters".

1.2. All persons entering (the "entrants") the Pick n Pay and Danone NutriDay KitchenAid® Smart Shopper Competition (the "promotional competition", alternatively the "competition") agree that the competition rules set out in these terms and conditions are binding on them. 2. IMPORTANT NOTICE

2.1. These terms and conditions and competition rules contain certain terms and conditions which:

2.1.1. may limit the risk or liability of the promoter or a third party; and/or

2.1.2. may create risk or liability for the entrant; and/or

2.1.3. may compel the entrant to indemnify the promoter or a third party; and/or

2.1.4. serve as an acknowledgement of a fact by the entrant.

2.2. The entrant's attention is drawn to these terms and conditions because they are important and should be carefully noted.

2.3. The entrant cannot be a juristic person and must be an individual.

2.4. Nothing in these terms and conditions is intended to, or must be understood to, unlawfully restrict, limit or avoid any rights or obligations, as the case may be, created for either the entrant or the promoter in terms of the Consumer Protection Act, 68 of 2008 (the "CPA").

2.5. The entrant acknowledges that, by submitting his or her entry to the competition, he or she has been given an appropriate opportunity to first read these terms and conditions before entering and understands and agrees to them.

2.6. All entrants to this promotional competition participate entirely at their own risk. By reading and accepting these terms and conditions, the entrant gives consent to these risks and hereby indemnifies and holds harmless the promoters, Danone, Pick n Pay, and all entities in the Pick n Pay and Danone groups respectively, their directors, employees and agents from any liability for damage, costs, injuries and losses of whatever nature sustained as a result of participation in the competition and related events and activities, save where such damage, costs, injuries or losses are sustained as a result of the gross negligence or wilful misconduct of any indemnified party.

3. RULES OF THE COMPETITION

3.1. This promotional competition opens at 00:01 on 27 July 2026 and closes at 23:59 on 06 September 2026.

3.2. The competition is open to all registered Pick n Pay Smart Shoppers nationally.

3.3. To enter the competition in-store, the entrant must purchase any participating NutriDay Plain product (6x100g, 450g or 900g) and swipe their Smart Shopper card for automatic entry.

3.4. To enter the competition online at www.picknpay.co.za or on the Pick n Pay asap! app, the entrant must purchase any participating NutriDay Plain product (6x100g, 450g or 900g) and link their Smart Shopper card to their online profile before checking out for automatic entry.

3.5. The prize: Entrants stand a chance to win one (1) of five (5) KitchenAid® Artisan Stand Mixers 4.8L, valued at R15 990 each.

3.6. Five (5) winners will each win one (1) KitchenAid® Artisan Stand Mixer 4.8L.

3.7. Participants may enter the promotional competition as many times as they wish, provided that each entry is associated with a separate qualifying purchase and Smart Shopper swipe. Irrespective of the number of participating products bought in each transaction, the transaction will result in one entry only.

3.8. Prizes are not transferable and may not be exchanged for cash or other prizes.

3.9. As stated in clause 2.6 above, the promoters shall not be liable for any damage, costs, injuries or losses sustained in relation to the competition, the prize or its enjoyment.

3.10. To qualify as an entrant for this promotional competition, the entrant:

3.10.1. must be resident in South Africa and/or hold the relevant permit to be in South Africa;

3.10.2. must provide correct and complete personal details, as required;

3.10.3. must be 18 years old or older;

3.10.4. cannot be a juristic entity and must be an individual; and

3.10.5. must be a registered Pick n Pay Smart Shopper.

3.11. Entrants are responsible for ensuring that the contact details linked to their Smart Shopper profile, including their mobile number and any other available contact details, are accurate and up to date before the competition closes. The promoters will use the contact details recorded against the entrant's Smart Shopper profile to contact selected winners.

3.12. The promoters, Danone, Pick n Pay, any entity in the Pick n Pay and Danone groups respectively, and their directors, members, partners, employees, agents or consultants, the suppliers of goods or services in connection with this promotional competition, or any other person who directly or indirectly controls or is controlled by the above-named parties, and their respective spouses, life partners, business partners or immediate family members, are not permitted to participate in this promotional competition.

4. SELECTION OF WINNERS

4.1. Winners will be selected within four weeks of the competition closure date (this date is subject to change without notice).

4.2. Entrants to whom prizes will be awarded will be selected through a random draw. The random draw will be overseen and certified by an independent person appointed by the promoters, who shall not be connected to the promoters, their associated companies, or any supplier involved in the competition.

4.3. Winners will be contacted using the contact details linked to their Smart Shopper profile within four weeks of the competition closure date (this date is subject to change without notice). The promoters will first attempt

to contact a selected winner via WhatsApp where available. If the selected winner does not have WhatsApp, cannot be reached via WhatsApp, or WhatsApp contact is otherwise unsuccessful, the promoters may contact the selected winner by telephone call, SMS and/or email, where such contact details are available.

4.4. A selected winner must respond to the winner notification within one week of the first successful notification attempt, or within such other reasonable period stated in the notification. If the selected winner does not respond within the required period, cannot be contacted using the contact details linked to their Smart Shopper profile, or has no valid contact details available, the promoters reserve the right to disqualify that winner and select a replacement winner by random draw. The same contact and response process will apply to any replacement winner.

4.5. The prize is awarded subject to successful verification of the winner's eligibility, qualifying purchase, Smart Shopper details and compliance with these terms and conditions. The promoters may request reasonable documentation or information from a selected winner, including proof of identity, proof of address, Smart Shopper card details and any other information reasonably required to verify the winner and facilitate delivery of the prize.

4.6. A selected winner must provide all information reasonably requested by the promoters within the timeframe specified in the winner notification. If the winner fails to provide the required information, provides incorrect or incomplete information, cannot be verified, is found to be ineligible, or otherwise fails to comply with these terms and conditions, the promoters may disqualify that winner and select a replacement winner by random draw.

4.7. The prize will be delivered to the verified winner at an address within the Republic of South Africa, as provided by the winner. The promoters will make reasonable efforts to deliver the prize within a reasonable period after verification of the winner, but delivery times may be affected by stock availability, supplier lead times, courier availability or other circumstances beyond the promoters' reasonable control.

4.8. The winner is responsible for ensuring that the delivery address and contact details provided are accurate and complete. The promoters will not be responsible for any failed, delayed or misdirected delivery arising from incorrect, incomplete or outdated details supplied by the winner.

4.9. The promoters, their agents or nominated courier may require the winner, or a person authorised by the winner, to sign an acknowledgement of receipt on delivery of the prize. Risk in and benefit to the prize will pass to the winner on delivery.

4.10. If the advertised prize becomes unavailable for any reason beyond the promoters' reasonable control, the promoters reserve the right to substitute the prize with another prize of equal or greater value, subject to applicable law. No cash alternative will be offered.

4.11. The prize does not include any accessories, services, warranties, insurance, costs or expenses other than those expressly stated in these terms and conditions. Any ancillary costs associated with accepting, using or enjoying the prize are for the winner's own account, unless expressly stated otherwise.

4.12. The promoters make no representations or warranties regarding the prize other than those provided by the manufacturer or supplier of the prize, where applicable. Any product warranty, guarantee, after-sales support, repair or replacement claim relating to the prize must be directed to the relevant manufacturer or supplier, subject to applicable law.

4.13. If the winner refuses, is unable or fails to take delivery of the prize after reasonable delivery attempts, the promoters may regard the prize as forfeited and may select a replacement winner by random draw.

4.14. The promoters will keep records relating to the selection and fulfilment of prizes as required under applicable law.

4.15. Pick n Pay and Danone reserve the right to amend these terms and conditions and to terminate the competition at any time. In the event of such termination, all participants agree to waive any rights that they may have in terms of the competition and acknowledge that they will have no recourse against Pick n Pay, Danone, their advertising agencies, advisors, suppliers and nominated agents, subject always to applicable law.

5. DATA PRIVACY AND POPIA

5.1. "Personal Information" has the meaning given to it in the Protection of Personal Information Act, 4 of 2013 ("POPIA") and includes information relating to an identifiable, living natural person and, where applicable, an identifiable, existing juristic person.

5.2. By entering this competition, entrants expressly consent to the collection and processing of their Personal Information by the promoters for the purposes of administering and managing the competition, including validating entries, conducting the draw, contacting and verifying selected winners, arranging and confirming prize delivery, keeping records required by law, and otherwise fulfilling the competition.

5.3. Entrants consent to the promoters sharing Personal Information with designated third parties, service providers and suppliers only to the extent reasonably necessary to administer the competition, verify winners, fulfil and deliver prizes, or comply with applicable legal obligations.

5.4. All Personal Information collected and processed in connection with this competition will be handled in accordance with POPIA and other applicable South African data protection and privacy laws, and will be treated as confidential and protected using appropriate safeguards.

5.5. Personal Information collected for the competition will only be processed for the purposes described in these terms and conditions, unless further processing is permitted or required by law or the entrant has separately consented to such further processing.

5.7. Entrants are responsible for ensuring that the Personal Information and contact details linked to their Smart Shopper profile are accurate, complete and up to date. Failure to maintain accurate contact details may prevent the promoters from contacting or verifying a selected winner.

6. GENERAL

6.1. By entering the competition in accordance with these terms, you are entering a promotional competition for purposes of the Consumer Protection Act, 2008 ("CPA"), and the promotional competition will be conducted in accordance with the relevant provisions of the CPA.
